## CONTRACT OF AGREEMENT FOODS AND DRINKS (SERVICE LUNCH FOR THE INCOMING PNPA GRADUATES)

#### KNOW ALL MEN BY THESE PRESENTS:

That this CONTRACT OF AGREEMENT made and entered into by and between;

The **BUREAU OF FIRE PROTECTION**, a government agency created by virtue of DILG Act of 1990 with office address at BFP National Headquarters Building, Brgy. Bagong Pag-asa, Agham Road, Quezon City represented herein by its **DIRECTOR LEONARD R BAÑAGO DSC**, **Chief BFP**, who is authorized to represent and bind said office in this Contract, hereinafter referred to as the **FIRST PARTY**.

#### and

MAGSINO'S BAKESHOP AND CATERING SERVICES, a business entity with principal office address at #28 Tamblot Street, Barangay Masagana, Project 4, Quezon City represented by MS IMELDA D MAGSINO to act for and in behalf of the company, hereinafter referred to as the SECOND PARTY.

#### WITNESSETH THAT:

WHEREAS, a Request for Quotation (RFQ) for the Foods and Drinks (Service Lunch for the Incoming PNPA Graduates who opted to Join the BFP) in the amount of **Seventy Thousand Pesos** (Php 70,000.00) was published at Philippine Government Electronic Procurement System (PhilGeps) website and other conspicuous place within the BFP premises;

WHEREAS, the SECOND PARTY is willing to deliver the required services as stated in its quotation form amounting to Seventy Thousand Pesos (Php 70,000.00) and comply with the requirements of the FIRST PARTY;

WHEREAS, the FIRST PARTY approved BFP Alternative Mode of Procurement Committee Resolution No 2018-SVP-018A dated 6<sup>th</sup> day of March 2018, recommending the award for the Foods and Drinks (Service Lunch for the Incoming PNPA Graduates who opted to Join the BFP) under Negotiated Small Value Procurement to the SECOND PARTY;

**NOW THEREFORE**, for and in consideration of the foregoing premises and mutual covenant, the parties hereto have agreed to the following terms and conditions:

#### ARTICLE I - SCOPE OF CONTRACT

- 1. The SECOND PARTY binds itself to deliver the required services on March 26, 2018 at 7<sup>th</sup> Floor Gen Madriaga Hall, BFP-NHQ, Agham Road, Brgy Bagong Pag-asa, Quezon City, Philippines;
- 2. The submitted documents, purchase request and request for quotation form shall be made as integral part of this contract, hereto attached;

#### ARTICLE II - CONTRACT PRICE

- As a consideration for the faithful performance and satisfactory accomplishment of all obligations of the SECOND PARTY under this contract the FIRST PARTY shall pay to the SECOND PARTY the total contract price of Seventy Thousand Pesos (Php 70,000.00) for the Foods and Drinks (Service Lunch for the Incoming PNPA Graduates who opted to Join the BFP); and
- 2. All fees, taxes and other similar charges, imposed by the Philippine Government shall be on the account of the **SECOND PARTY**:



#### **ARTICLE III - TERMS AND PAYMENTS**

- 1. The duty performance shall be rendered by the **SECOND PARTY** upon receipt of Notice to Proceed at BFP National Headquarters Building, Agham Road, Brgy Bagong Pag-asa, Quezon City, Philippines.
- 2. The full amount of the total contract price shall be paid by the FIRST PARTY payable in favour of the **SECOND PARTY**, only after the submission of the billing statement of the Foods and Drinks (Service Lunch for the Incoming PNPA Graduates who opted to Join the BFP);

#### **ARTICLE IV - FORCE MAJEURE**

- 1. The SECOND PARTY shall not be in default under this contract for any delay in the PROJECT caused by force majeure or fortuitous event, provided that the SECOND PARTY informs the FIRST PARTY in writing of such delay within ten (10) days after the cause of occurrence of the delay. Upon receipt of such notice of delay, the FIRST PARTY shall promptly ascertain the facts and the extent of the delay. The FIRST PARTY's decision shall be binding upon the SECOND PARTY;
- 2. No extension of time shall be granted to the **SECOND PARTY** if notice of delay is made after the expiration of the delivery as provided under this Contract;

#### **ARTICLE V - PENALTY CLAUSE**

In case the SECOND PARTY fails to effect the Project without any fault on the part of the FIRST PARTY an amount equivalent to one tenth of one percent (1/10 of 1%) of the total value of the undelivered units shall be deducted each day of delay as penalty. A penalty shall be deducted from any source that may be payable to the SECOND PARTY or levied upon the performance bond;

#### **ARTICLE VI - ARBITRATION**

Any dispute or unresolved differences arising out of or in connection with this contract that cannot be amicably settled by and between parties thereto, shall be referred first for arbitration in Quezon City, Philippines before recourse to Courts of competent jurisdiction shall be availed of;
